Fifty Years of Reflection... and a Future to Build Maison du Futur, Bickfaya Friday, 5 December 2025

Ladies and Gentlemen, Dear friends.

It is up to us, starting today, to undertake an internal process of renewal founded on sound, transparent, and accountable governance. Only then can we strengthen Lebanon's resilience and protect its future.

Our country lacks neither talent nor competence. What it needs is an institutional framework that values integrity, encourages innovation, and supports social justice.

This conference is not intended as a nostalgic assessment. Its ambition is to open a space for ideas, reflection, and proposals for the years ahead. It is in this spirit that we have asked each of our speakers to formulate one key recommendation drawn from their

experience and expertise. These proposals will be discussed, enriched, and integrated into a Policy Paper that the Maison du Futur, in partnership with the Konrad Adenauer Foundation, will publish following this gathering. This document will serve as a solid foundation for continuing reflection and inspiring concrete initiatives.
